Description

- 1. The Special Bonus Scheme (SBS) exists to reward exceptional performance by eligible civilian staff in an extraordinary task or exercise. MOD Personnel Instruction 124/99 announced the extension of the Scheme to allow for the recognition of significant personal development achievement such as the attainment of a professional or educational gualification of national standing.
- 2. The directions and guidance for the use of the SBS for Qualifications is contained in the Policy, Rules and Guidance (PRG) document, 'Rewarding Performance through the Special Bonus and Minor Award Schemes'. Available on the Defence Intranet at:

The test for eligibility of a qualification within the SBS scheme requires Line Managers to decide whether qualifications are appropriate or relevant either to the current role, or the wider requirements of the TLB and MOD. This Bulletin is to be taken as a formal declaration of the DE&S requirement for these professional achievements in relation to Acquisition Environment.
